<u>Section 2</u>. Brenan Way (North Portion) as specified in Exhibit "B", which exhibit is attached hereto and made a part hereof, is hereby laid out and adopted as a public road in York Township, York County, Pennsylvania.

<u>Section 3</u>. Kavanagh Cirlce as specified in Exhibit "C", which exhibit is attached hereto and made a part hereof, is hereby laid out and adopted as a public road in York Township, York County, Pennsylvania.






