Comm. Steele announced that the Board would meet to discuss personnel matters at the end of the meeting.

Public Comments

Jerry Smith, 17 Merrin Road – Mr. Smith offered comments regarding the Zoning Hearing Boards' denial of the appeal of granting a permit to Dallastown School District to place a driveway on its property and connect that driveway to Merrin Road. He expressed concerns over the increased traffic on Merrin Road and its condition. He asked the Board to bring Merrin Road up to current construction standards.

Budget Presentation -Larena Keller and Gary Milbrand

Larena Keller thanked the directors for their input and the Board for meeting one on one and reviewing the budget prior to the workshop. The Workshop presentation is included in the official minute book.

A discussion was held.

The general fund millage will remain at 1.24 mills, and the fire tax will increase by .13 mills to .50 mills. The Board agreed to make contributions to the following:

Golden Connections \$30,000

Kaltreider-Benfer Library \$25,000

York County and Dallastown High School Science Fairs \$900

Fire Company Scholarships \$5,200

Jessica and Friends \$175 York County Advanced Technical Rescue \$1,000 4% Fire and EMS increase in general contributions and a special program contribution of \$250,000. Retention and Recruitment remain the same.

Sewer rates are to remain the same for 2024.

Larena Keller advised that she would present the budget reading at our November 12, 2024 meeting.

Commissioners Comments

Comm. Cronin – Read a statement on how the volunteer fire departments play a crucial role in ensuring the safety and well-being of our community, and they deserve our support. He noted the significant challenges of volunteer fire companies and that improving the business operations side will make volunteer fire departments more sustainable and effective. He encourages the recent efforts of the Goodwill Fire Company # 1 of York Township and the Southern Area Fire and Emergency Rescue to move towards a unification of resources, personnel, and operations to create a more efficient and effective service. He noted today's proposed funding increases is an investment in the safety and resilience of our community.

Comm. Steele – Reported that on October 19, 2024, he attended the viewing of "Honorable but Broken, EMS in Crisis." He noted that the message from the movie was that Townships and Boroughs should provide funding for EMS as they support vital services like fire and police.
