#### **Public Comments**

#### Colin Kowalewski – 32 Merrin Road

Mr. Kowalewski advised the Board he received a citation for walking his dog on his street from the Dallastown School Resource Officer. He asked about a speed study.

### Nicole Widger – 32 Merrin Road

Ms. Widger commented on the new entrance to the school from Merrin Road. She asked the Township to take another look at the harmful situation the school entrance has caused all parties.

#### Corporal Hess, York County Regional Police

Corporal Hess stated she was aware of the issues with Merrin Road. She stated on Monday, Lieutenant Krzywulak placed postings for off-duty patrol officers to monitor Merrin Road before school hours and after. She noted in the future it will be addressed by regular road officers rather than the SRO's.

Solicitor Jones stated the results of the speed study are complete. He noted Mr. Kowalewski can request the results from the police department.

# Engineer - Mike Hiras JMT and Director of Economic Development -Lisa Frye Applications/Plans Time Extension Approval

## a. P2025-1-1 Wellspan Subdivision, 2500 South George Street

The request was presented by Ryan Herbst, Site Design Concepts

Mr. Hiras stated the plan involves a subdivision lot line adjustment. There are no other changes and no construction is proposed throughout the remainder of the property.

Mr. Hiras provided an update on the 2025 Math Counts Competition for Dallastown Middle School where he is one of the coordinators. The school placed 12<sup>th</sup> out of 20 schools.

- He attended the funeral of Officer Andrew Duarte who was killed while on duty during the incident which occurred at UPMC Memorial Hospital.

- He addressed the subject of trash pickup. He noted he takes care of trash pickup on several road within the Township. He is proposing to present to the Board a program to post signs along roadways for individuals/groups.

- He attended the Jacobus Lions Club meeting at which Lance Beard, Mayor of Jacobus, presented a program on DUI Impaired Driving.
- He attended the Dallastown girls basketball game March 7, 2025 at which they defeated Abington High School. The Dallastown basketball team continued in the state playoffs and were crowned District 3 champions.
- He congratulated Avery Baldwin, a girls wrestling representative of Dallastown High School who finished 7<sup>th</sup> in the state competition.
- He attended the SAFER Banquet on March 8, 2025.
- He attended the Station 19 meeting on March 10, 2025.
- He participated in the York County Science and Engineering Fair held March 11, 2025, as a presenter for the York Township awards in the York County Science Fair in water quality and stormwater management.

#### Comm. Cronin

Comm. Cronin provided an update on the situation in the Merrin Road neighborhood regarding the York Township Elementary School drop-off and pickup traffic. Using PowerPoint, he presented a photo of vehicles parked along Merrin Rd that obstructed school traffic and an aerial overview of the neighborhood clearly showing adequate driveway space demonstrating no apparent need for on-street parking. Comm. Cronin explained he was in communications with the police and reported that 3 arrests have been made for two residents both charged with obstructing traffic. Comm. Cronin presented a speed study undertaken by the police showing that from 12/11/2024 through 12/14/2024 90% of the 378 vehicles recorded were traveling under 25 mph, 38 or 10% were over 25 mph but none exceeded 33 mph. Additionally, vehicles that were over 25 mph were distributed evenly among school traffic time and non-school traffic time. This data suggests speed is not creating a significant threat to the safety of the neighborhood. He

indicated a discussion should be held for a solution to put up no parking signs between 8 AM and 9 AM, and 3 PM and 4 PM when school is in session.

- Comm. Cronin attended the Station 19 meeting on March 10, 2025, and they voted to merge with SAFER.

#### Comm. Steele

- He attended the York County Regional Police Commission meeting on February 13, 2025
- He attended the Parks & Recreation meeting on February 26, 2025 regarding the park master plan.
- He attended the SAFER Appreciation Dinner on March 8, 2025. He commented attending the event showed him the commitment of the citizens.
- He brought up a decision made by the Commissioners several months ago regarding the burn ordinance, which Comm. Cronin had spent time reviewing and outlining revisions, with the support of the solicitor and Ms. Frye. Comm. Steele recommended the proposed revisions be put on the agenda.

Ms. Frye confirmed she worked with Comm. Cronin, Mr. Myers and Solicitor Hovis. She noted the language of the current ordinance is somewhat confusing and has led to several misunderstandings. She suggested looking at the language of the ordinance in attempting to make it more user and reader friendly.
