* HOW TO OBTAIN A FENCE PERMIT *

(Last Updated: April 10, 2024)

Step #1: <u>Review Ordinance Requirements</u>

Height:

- 1. Maximum height in side and rear yards is six (6) feet
- 2. Maximum height in front yards is four (4) feet (corner lots have two front yards).

Location:

- 1. Fences may be placed directly on your side of the property line. Property owners are responsible for making sure their fence does not cross onto a neighboring property. If you are unsure of the exact location of your property lines, consider hiring a professional surveyor to locate your property lines.
- 2. Fences may not be placed within any easements or right-of-ways for sanitary sewer or stormwater purposes, unless prior approval is granted.
- 3. Request underground utility line locations to be marked prior to digging on your property by calling 811 or registering on the Pennsylvania One Call System website at <u>pa1call.org</u>
- 4. Fences are not permitted within street right-of-ways.
- 5. Fences in front yards of corner lots may not obstruct vision in clear-sight triangles. (see attached)

Miscellaneous:

- 1. The finished side of the fence must face adjoining properties or street.
- 2. There are no regulations regarding the type of material used for fences.
- 3. Unless the fence surrounds a swimming pool and is acting as the required pool barrier, there are no regulations regarding the style of fences.
- 4. One inspection is required to verify location and height of the fence.
- 5. Fences meant to satisfy swimming pool safety requirements must be at least four feet high and have no openings greater than four inches. Gates in these fences must be self-closing, self-latching, and open away from the pool. Please contact the Township if you have additional questions regarding required pool fences.

<u>Step #2:</u> <u>Complete Application Form</u> (see attached)

<u>Step #3:</u> <u>Prepare a Plot Plan on the Back of the Application or on a Separate Sheet of Paper</u> (see attached)

<u>Step #4:</u> Submit the Application and Plot Plan at the Township Office

- 1. After submission, review, and approval, you will be notified that the permit is ready to be picked up.
- 2. The cost of the permit is **\$25.00** + **\$50.00** per zoning inspection. The fee is payable in cash or by check made payable to York Township.

Step #5: Post the Permit Card in a Front Window of the House Where it can be Seen

<u>Step #6:</u> Install Fence – Permit is Valid for One Year


